His entire College education was completed from Marathwada University Aurangabad, including, B.A. (1975), LL.B. (1978), Dip. in Labour Law (1982) (Merit-II in University), LL. M. (1980) (I st Merit in University) and Ph.D. in Law (2006). Was recipient of National Merit Scholarship in LL.B. & LL. M.
